## **Consideration**

### You can also say that in a few words:

It is just a loving reminder that we start with ourselves and look inward to see where we ourselves can improve and change our behavior. And hopefully that rubs off on those around us who may not be as considerate in their behavior.

Motorhome tourists can achieve goodwill by complying with a set of ethical guidelines, which essentially only concern that we behave in a way that we show consideration for others and do not necessarily demand our rights.



#### Emptying etc.

Only empty waste water and toilets where there are facilities for this. Never flush the toilet in toilet bowls. Emptying facilities and the possibility of fresh water are available at many rest areas on the motorways. If the bin is full, you take your rubbish with you. Don't put it aside just because something might already be there.

# **Apps and Free Camping**

There are countless websites and apps that tell you where you can spend the night. The vast majority are serious apps that only have slots that have been created with care. However, there are apps where everyone can enter places that they think are good, but that they have not informed themselves about the legality and morality of spending the night there. This is where conflict can arise with municipalities and landowners. Several municipalities are dissatisfied with the motorhomes parking for the night, where it is inappropriate and where both municipalities and landowners have not been asked whether it is ethically correct to park in that particular place.

Precisely for this reason, you must always form an overview of the place you have driven into:

- \* Are there signs with restrictions or prohibitions?
- \* Are you alone at the site?
- How far is it to the nearest residence, or other building that may have an opinion on your accommodation? If in doubt, ask permission to park there for a night.
- How is the site in relation to public paths, public areas and places where people move?

- Motorhome pitches with or without facilities.



If you want to use any of the options below, it must always be done on a campsite and motorhome pitch.

If you want to spend the night outside the pitches in the five pitch types, where there is almost always room, the AutoCamper Council encourages you to comply with these simple rules:

- Do not disturb the surroundings and do not
- Do not park on private property without permission.

Park only where it is legal and where not is signposted prohibiting motorhomes.
